Chair's Comments

Dear Friends and Members

This newsletter is, as much as it is an update on our recent activities, to publicise the AGM on November 17th at the Unitarian Meeting House at 7.30pm. This will be our first face-to-face meeting since February 2020, so it is with a mixture of excitement and trepidation that I, for one, approach it.

We have our own health and safety risk manager in Paul Rynsard, who has set out a plan to ensure we are as safe as possible but please do expect there to be open doors for ventilation,

so if you are coming do wear warm clothes and, because of the alarming rise in cases we are asking folks to have a lateral flow test too. We'll be having the usual drink pre meeting and after the business Paul Rynsard and I will update you about what has been happening over the last year at 11 High Baxter Street with an illustrated talk.

Otherwise, John Popham has been chivvying us up to take some action to help the owners of historic buildings wishing to lower their carbon footprints, and this is a matter we are now gearing up to address with Aoife O'Gorman convening a working group.

I was alerted to the urgency of the issue when the Suffolk County Council invited me to take up the chance to have 'Solar Panels' added to the roof of my house. Well, I, like very many of us, live in a listed building and so I know that to install such panels would require listed building consent, which in the case of my house would certainly not be granted. So, I took this up with the excellent conservation officers at West Suffolk Council, who have now asked the County Council to make it clearer that this is not a straightforward matter where listed buildings are concerned.

Having said that, the BTT is signed up to 'Heritage Declares' and firmly believes the historic environment does have to play its part in solving the climate crisis. But the old 'babies and bath water' analogy is appropriate here as what is needed is an approach to the historic environment, and individual elements/ properties in it, which

ensures the 'special interest' and 'character' of listed buildings and conservation areas survive any such changes.

Historic England advise a 'whole building' approach be taken, so that all sorts of options are explored to ensure the least invasive/ harmful changes only are adopted. Indeed, there are ways that historic buildings can be made more sustainable that are benign and wouldn't 'harm' either their significance, or their setting.

The BTT hope over the next few months to put together some guidance for property owners on where they can get coordinated and sensible advice and this will be included on our website.

In the meantime, if you have been attracted by such offers as those from the County Council do bear in mind you may need listed building consent or even planning permission if you live in a conservation area. You would be advised to take advice from a suitably qualified professional.
