### WHAT DOES THE BTT DO?

BURY ST EDMUNDS TOWN TRUST aims to help conserve and bring back to use the built heritage in Bury St Edmunds, and to ensure its survival for the benefit of society both today and in the future.

The Trust is a charity which carries out its aims in practical ways, by undertaking projects that repair and enhance what is important in the historic environment, and by providing student training and scholarships in historic building conservation.

### BEING A MEMBER

The BTT is managed by a board of Trustees who welcome the involvement of all who have a love for our town and its historic environment, and are enthusiastic to support its well-being.

Members are encouraged to get involved with our projects to enhance our historic town.

The board issues Newsletters to keep members up to date with our activities and we have talks and presentations at local venues too.

As a Registered Company limited by Guarantee, BTT's Memorandum and Articles of Association are as required by the Companies Act 2006. Every Member promises that if the Company is dissolved whilst he/she is a Member, and if required, he/she will contribute a sum not exceeding 10 towards any BTT debts or liabilities.

### SOME CURRENT PROJECTS

Since its foundation in **1979**, BTT has bought many unloved historic buildings in the town, restored them and found viable long term uses to ensure their survival.

**In 2013** the Trust, together with West Suffolk College, initiated and sponsored a free course for trade students in historic building conservation. In 2019 this became a BTEC Level 3 course, Construction and Conservation in the Built Environment, the first of its type in England. The Trust also sponsors an annual College award for the outstanding conservation student of the year.

**Since 2015** BTT has led the campaign and worked with other organisations to try and ensure the town's listed railway station is properly repaired and its facilities enhanced.

**During 2019**, Trust members prepared a gazetteer of significant historic buildings not protected by listing. This has been endorsed and welcomed by West Suffolk Council.

**Since 2019**, BTT's project has been to restore 11 High Baxter Street, a 15th C house derelict after years of neglect.
